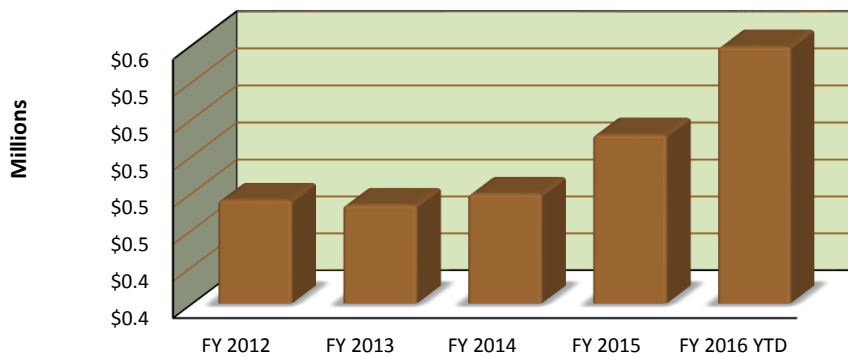

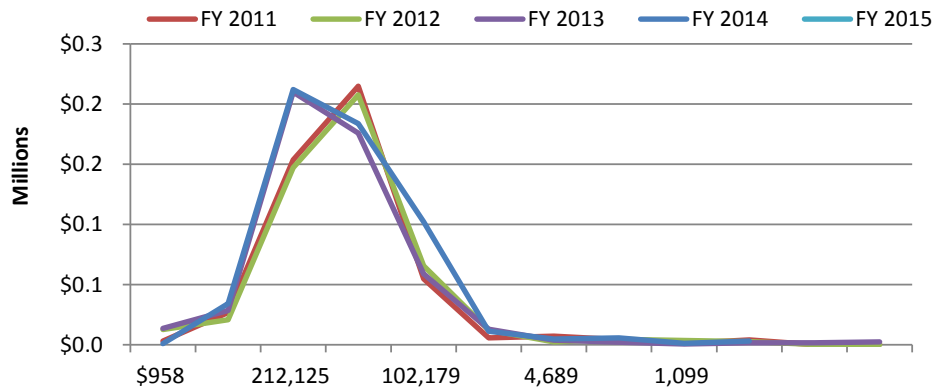

**Property Tax Revenue by Month**

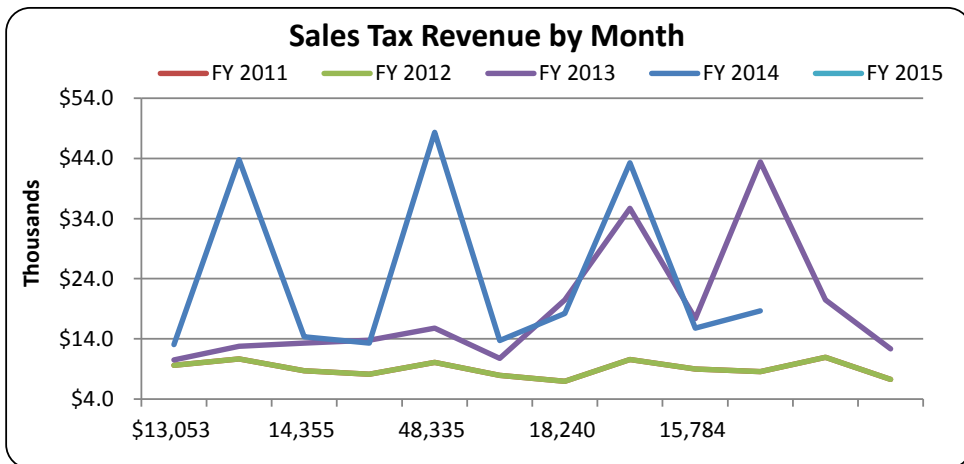
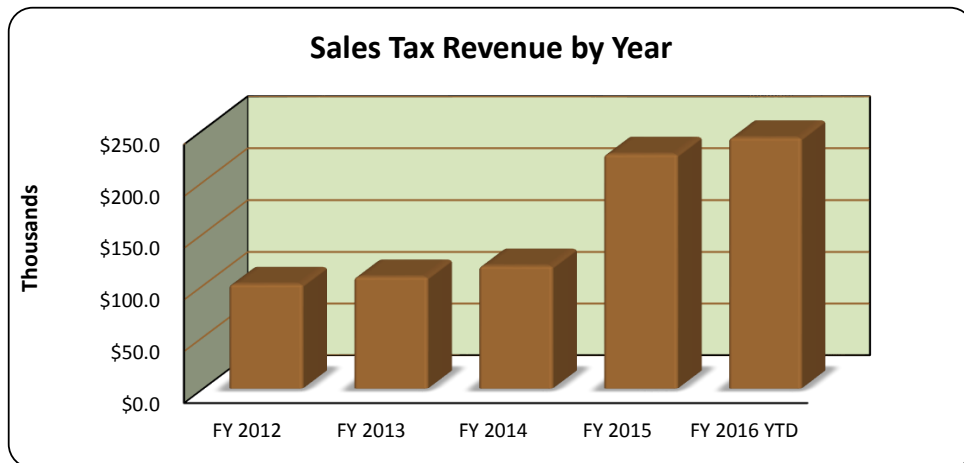

**Fines & Forfeitures Revenue by Month**



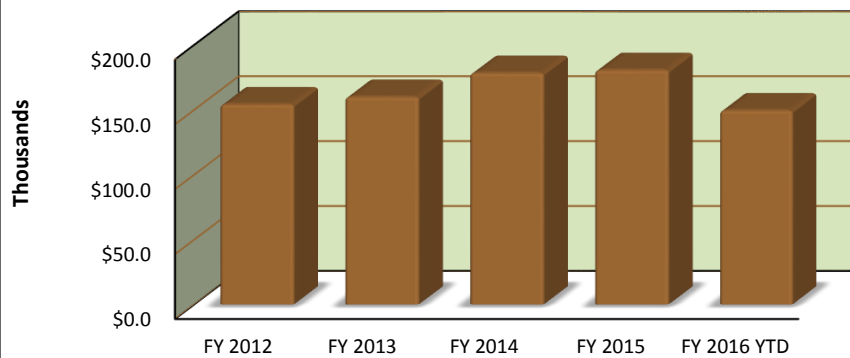

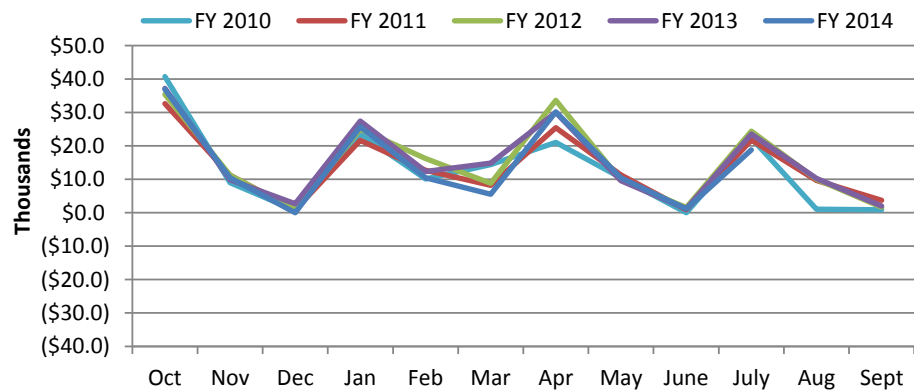

### Franchise Fee Revenue by Month

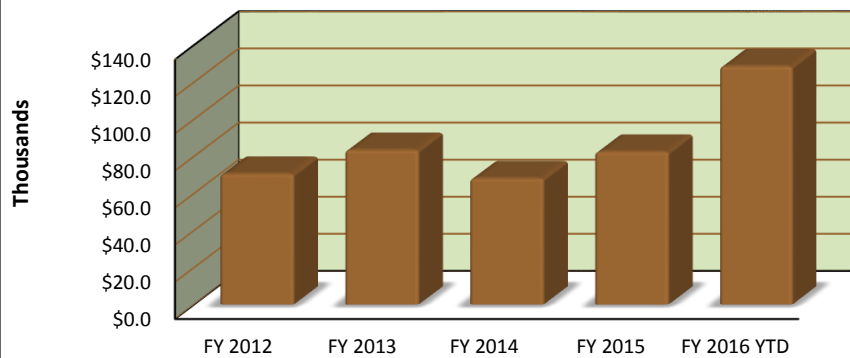
