I UNDERSTAND THAT I MUST:

- Complete a driving safety course, motorcycle training course, or seat belt course as applicable;
- Submit by \_\_\_\_\_ a certificate of completion of class as evidence that I have completed the course as ordered by the Court;
- Submit by \_\_\_\_\_ a certified copy of my driving record as maintained by the Texas Department of Public Safety;

**Check only if ordered:** \_\_\_\_\_ The Defendant being a holder of a provisional driver's license is ordered to submit for a driver's license examination as required by Section 521.161(b)(2), Transportation Code, regardless of whether the defendant was previously examined, and pay a \$10 examination fee to the Department of Public Safety.

I UNDERSTAND THAT:

If I comply with this order, take the above ordered course and submit all the required evidence as ordered the COURT WILL DISMISS my case and report to the Texas Department of Public Safety the date that I completed my course for inclusion on my driving record. **FAILURE TO SUBMIT ALL THE EVIDENCE REQUIRED AS ORDERED BY THE COURT** will result in a SHOW CAUSE HEARING where I must appear before the Court to show cause why I did not present the evidence as ordered by the Court. At the show cause hearing, the Judge may enter a final judgment against me and require me to pay the fine immediately. **FAILURE TO APPEAR AT THE SHOW CAUSE HEARING WILL** result in final judgment with all fines due and payable immediately. THE COURT MAY ASSESS THE MAXIMUM FINE OF \$200 PLUS COURT COSTS AND A CAPIAS PRO FINE WARRANT WILL BE ISSUED FOR MY ARREST.

# DRIVERS SAFETY CHECK LIST

## TEXAS DRIVING RECORD INFORMATION

✓ If you mail your order form for your Texas Driving Record it will take 4-6 weeks to get the record back in the mail. You may order the record online and print the record immediately by logging on to <http://www.texas.gov> **ORDER VERSION: 3A**

✓ The Court **WILL NOT** accept a driving record that was ordered after the original due date on your court order.

## DEFENSIVE DRIVING INFORMATION

✓ It will take at least 2 weeks for you to receive a certificate of completion back from the course provider via mail. The Court **WILL NOT** accept a certificate that was completed after the original due date noted on your court order.

✓ Make sure you give the course provider the correct name of the City you are doing the course for: **TOWN OF BARTONVILLE.**

✓ **The certificate of completion submitted must meet the following criteria:**

It must be an original **"COURT COPY"** and be signed by you.

It must have the **TOWN OF BARTONVILLE** as the Court Name.

It must have a completion date on or before your original due date noted on your court order.

✓ **COURSE PROVIDER LIST:** The Court cannot recommend a specific course provider, but you may use the following link to help locate a State TDLR & 6 HOUR (Texas Department Licensing Regulations) approved driving safety course provider:
