Mayor Ron Robertson called the meeting to order at 9:05 a.m.

**Call to Order**

The Council participated in a work session and considered appropriate action regarding the Fiscal Year 2006-2007 Proposed Budget and the 2006 Ad Valorem Tax Rate. Town Secretary Debbie Millican presented the preliminary budget estimates and the effective tax rate calculations for the upcoming Fiscal Year.

**Work Session**

Dave Howell moved: A) to authorize the Mayor to enter into an Interlocal Agreement with Denton County for Patrol Services for Fiscal Year 2006-2007. B) authorize the Mayor to enter into an agreement with the Argyle Volunteer Fire District for Fiscal Year 2006-2007 Emergency Services. C) to approve, for public inspection and comment, at Bartonville Town Hall, the Proposed Preliminary Budget and Tax Rate for Fiscal Year 2006-07, dated July 29, 2006 and to set a public hearing for Tuesday, August 15, 2006, to hear public comment before the final adoption on September 19, 2006. D) to authorize the Mayor to enter into an employment agreement with Debbie E. Millican, to serve as Town Administrator beginning October 1, 2006. and E) to approve Ordinance 402-06, an ordinance of the Town of Bartonville providing a schedule of fees to be collected. Wayne Hoyt seconded the motion. For: Unanimous. The motion carried 3 to 0.

**ACTION: Approve and Authorize Preliminary Budget/Contracts**

Dave Howell moved to authorize the Mayor to make an offer of employment for the position of Administrative Assistant/Permit Clerk to Amanda Silva. Carla Anderson seconded the motion. For: Unanimous. The motion carried 3 to 0.

**ACTION: Hire Permit Clerk**

Mayor Robertson presented a draft of Ordinance 401-06, defining commercial vehicles; regulating their use within the corporate limits of the

**ACTION: Table Truck Ordinance**

Town of Bartonville; and establishing permit and bonding requirements. He stated that the ordinance was in draft form and needed further revision before adoption. Dave Howell moved to table any action regarding Ordinance 401-06. Wayne Hoyt seconded the motion. For: Unanimous. The motion carried 3 to 0.
