The statutory first day for filing falls on Saturday, February 4 th . (If the statutory filing date falls on a Saturday, the first day to file goes to the next business day – Monday, February 6 th .)
Feb 20	Town Offices Closed in Observance of Presidents Day.
Mar 5	Last day for candidate to file application for a place on the ballot. DEADLINE – 5:00 P.M. TOWN SECRETARY'S OFFICE
Mar 5	Last day for a write-in candidate to declare candidacy. DEADLINE – 5:00 P.M. TOWN SECRETARY'S OFFICE.
Mar 6	Town Secretary conducts drawing for order of names on the ballot in Town Council Chambers, Bartonville Town Hall. TIME – 8:00 A.M.
Mar 6	Last day for write-in candidate to withdraw.
Mar 8	Last day for candidate to withdraw candidacy. DEADLINE – 5:00 P.M. TOWN SECRETARY'S OFFICE.
Mar 13	First day for applying to receive a ballot for early voting by mail.
Apr 6	Town Offices Closed in Observance of Good Friday
Apr 12	Last day for submitting voter registration application in time to vote on May 12, 2012, or to request transfer of registration.
Apr 12	Due date for filing first report of campaign contributions and expenditures of opposed candidates, certain specific purpose committees, and all general purpose committees. DEADLINE – 5:00 P.M. TOWN SECRETARY'S OFFICE.
Apr 26	Candidate's Forum – 7:00 p.m. Bartonville Town Hall CANCELED
Apr 27	Last day for the Denton County Elections Administrator to receive applications in person for a ballot to be voted by mail. DEADLINE – 5:00 P.M. DENTON COUNTY ELECTIONS ADMINISTRATOR

- Apr 30 First day for Early Voting by personal appearance. Times and locations to be determined by the Denton County Elections Administrator. Visit elections.dentoncounty.com for details.
- May 4 Due date for filing second statement of campaign contributions and expenditures of opposed candidates, certain specific purpose committees and all general purpose committees. **DEADLINE – 4:30 P.M. TOWN SECRETARY’S OFFICE.**
- May 4 Last day for Denton County Elections Administrator to receive applications by mail for a ballot to be voted by mail. **DEADLINE – 5:00 P.M. DENTON COUNTY ELECTIONS ADMINISTRATOR**
- May 8 **Extended hours for Early Voting – 7:00 a.m. to 7:00 p.m. LAST DAY for Early Voting by personal appearance. DEADLINE – 7:00 p.m.**
- May 12 **ELECTION DAY** 7:00 a.m. to 7:00 p.m. Unofficial tabulation of results.
- May 15 Regular Monthly Meeting of Town Council – 7:00 p.m.
- May 18 **First day newly elected officials may qualify and assume duties of office after being sworn in.**
- May 21 **Official Canvass of Election Results** by Town Council at Bartonville Town Hall – 6:30 p.m. Mayor issues Certificates of Election to newly elected officials. Statement of Elected Officials Oath and Oath of Office are administered to candidates who appear to have won.
- Jun 19 Regularly scheduled Town Council Meeting.
- Jul 16 Due date for filing semiannual report of campaign contributions and expenditures for all candidates, all specific purpose committees, general purpose committees and certain officeholders. **DEADLINE – 4:30 P.M. TOWN SECRETARY’S OFFICE.**
